belonging to weaker section (10%) and disadvantaged group (15%) in the neighbourhood and provide free and compulsory elementary education till its completion.

- 3. For the children referred to in paragraph 2, the school shall be reimbursed in accordance with the provisions of sub-section (2) of section 12 of the Act. To receive such reimbursements the school shall maintain a separate bank account.
- 4 The Society / School Management shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
- 5. The school shall not deny admission to any child for lack of proof of age and shall adhere to the provisions of section 15 of the Act. The School shall ensure that:
  - Le No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
  - n. No child shall be subjected to physical punishment or mental harassment;
  - Mo child is required to pass any Board examination till the completion of elementary education:
  - Every child completing elementary education shall be awarded a certificate as laid down under rule 25.
  - Inclusion of students with disabilities/special needs as per provisions of the Act.
  - down under section 23(1) of the Act. Provided further that the existing teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualifications within a period of 5 years of commencement of the Act.
  - The teachers perform their duties specified under section 24 (1) of the Act and under rule 21.
  - The teachers shall not engage himself or herself in non educational and private teaching activities.

- 6. The school shall follow the syllabus on the basis of curriculum laid down by State Government / educational authority.
